CONTINUING GUARANTY

In consideration for, and as an inducement for, PROMOCENTRIC, INC. extending credit and selling merchandise to _____ located at _____ (hereinafter called the "Customer") the undersigned, _____ (hereinafter called the "Guarantor") unconditionally guarantees to pay Promocentric when due any indebtedness of the Customer heretofore or hereafter incurred for merchandise sold by Promocentric to the Customer. "Indebtedness," as used herein, is defined by its most comprehensive sense, including but not limited to, any and all past, present and future orders, invoices, bills, statements, liabilities, advances, judgments, loans, expenses, lines of credit, interest, debts and any other financial obligation the Customer owes to Promocentric.

This shall be an open and continuing guaranty and shall continue in force notwithstanding any change in form or amount of indebtedness or renewals or extensions of time granted by Promocentric without obtaining consent thereto, or by complete or partial release or settlement by Promocentric with the Customer, or any other person, and until expressly revoked by written notice received by Promocentric by registered mail. Such revocation when received shall apply only to and affect indebtedness thereafter incurred.

Notice of every kind or nature, including but not limited to notice of acceptance of this guaranty, indebtedness and default in payments, are hereby waived. This guaranty may be enforced by Promocentric against the undersigned without first proceeding against the Customer, or any other person or guarantor. It is further understood that there are no conditions or limitations to the guaranty except those stated herein.

Applicable Law. This Guaranty has been delivered to Customer and accepted by Customer in the State of New Hampshire. If there is a lawsuit, Guarantor agrees upon PromoCentric's request to submit to the jurisdiction of the courts of Rockingham County, State of New Hampshire. This Guaranty shall be governed by and construed in accordance with the laws of the State of New Hampshire.

Attorneys' Fees; Expenses. Guarantor agrees to pay upon demand all of PromoCentric's costs and expenses, including attorneys' fees and PromoCentric's legal expenses incurred in connection with the enforcement of this Guaranty. Promocentric may pay someone else to help enforce this Guaranty, and Guarantor shall pay the costs and expenses of such enforcement. Costs and expenses include PromoCentric's attorneys' fees and legal expenses whether or not there is a lawsuit, including attorneys' fees and legal expenses for bankruptcy proceedings (and including efforts to modify or vacate any automatic stay or injunction), appeals, and any anticipated post-judgment collection services. Guarantor also shall pay all court costs and such additional fees as may be directed by the Court.

EACH UNDERSIGNED GUARANTOR ACKNOWLEDGES HAVING READ ALL THE PROVISIONS OF THIS GUARANTY AND AGREES TO ITS TERMS. IN ADDITION, EACH GUARANTOR UNDERSTANDS THAT THIS GUARANTY IS EFFECTIVE UPON GUARANTOR'S EXECUTION AND DELIVERY OF THIS GUARANTY TO PROMOCENTRIC AND THAT THE GUARANTY WILL CONTINUE UNTIL TERMINATED IN THE MANNER SET FORTH HEREIN. NO FORMAL ACCEPTANCE BY PROMOCENTRIC IS NECESSARY TO MAKE THIS GUARANTY EFFECTIVE. THIS GUARANTY IS DATED _____. THIS GUARANTY IS EXECUTED UNDER SEAL.
